




Annex II – EU policy context Renewed ambitions



As Europe and the world enters the decade leading up to 2030, the Covenant of Mayors - Europe continues to ensure that the three pillars (mitigation, adaptation and energy poverty)

are turned into the overarching priority of our times

and that ambitious action follows.



In view of

the forthcoming decades,

the European Union has renewed its ambition by championing the adoption of the European Green Deal. This sets a reduction target of greenhouse gas emissions by at least 55% by 2030 and a long-term vision to reach climate neutrality by 2050.

These objectives - as enshrined in the 2030 Climate Target Plan and the European Climate Law - are to be achieved through a transformational change happening in all sectors of our society. A transformational change that involves all levels of governance.

The Covenant of Mayors - Europe is uniquely placed to embrace these renewed commitments and step up action.

The Climate Pact is promoting real collaboration between cities and a whole range of other actors, including business, not-for-profits and citizens, with the aim of achieving common goals and accelerating the climate transition. Signatory cities to the Covenant and their mayors can get involved in the European Climate Pact in many ways.

PARTICIPATE IN THE CLIMATE PACT

Make your commitment count as a pledge.

Signatories of the Covenant can register their commitment to a fairer, climate-neutral and resilient future as a pathway pledge¹ under the Climate Pact. Your city will be profiled on the Climate Pact website and you will get the opportunity to connect with other stakeholders, support deliberative engagement with citizens, and enable further pledges together with your citizens.





Apply to be an ambassador.

Your city's mayor (or another relevant representative) can become an ambassador to inform, inspire and support climate action across the Climate Pact community. This role is recognised by the European Commission and can bring greater visibility to the climate action that your city is taking.



Support deliberative engagement.

A number of deliberative formats are developed in the Climate Pact, including Peer Parliaments and other forms of prototyping for action, which can empower citizens to make their voices heard in the climate policy discourse. Engage your citizens by encouraging them to take part and show your commitment to listen and collaborate.
