Dear Culture Next Full Members,

As a Full Member, your city commits to actively contributing to the network's activities — including keeping your information updated, engaging in at least one activity annually, hosting cultural workers, and paying an annual fee of €3,000. In return, your city gains access to a wide range of benefits, such as participation in eight international conferences (with travel and accommodation support), mobility funds for cultural workers, priority in applying to host events, and the opportunity to influence cultural policy at European level through the network's advocacy and collaborative initiatives.

Before moving forward, I kindly ask you to:

- 1. Confirm if the document is accurate from your side and if you do not need to request any changes. If you identify any issues or wish to propose amendments, please inform me as soon as possible, before moving on whit the
- 2. Let me know if your organisation can sign this agreement using the DocuSign platform (https://www.docusign.com/) or if, for legal or procedural reasons, you are required to proceed through traditional email exchange and signed documents (ink or digital). If you are comfortable with the platform, you will, after your feedback, receive a DocuSign link in your inbox, allowing you to sign the agreement digitally. The plataform if free for you and no need to sign in whit the link we will generate.

Depending on your feedback, I will proceed accordingly with the next steps for formalisation.

Anouther reminder: if the signing entity is not a city (by which we mean a municipality or local authority), please make sure to send us a signed declaration from the city confirming that your organisation is officially recognised to represent it in the Culture Next network. We include as an attachment a template declaration which can be used or adapted to your local context. The declaration must be in English, though bilingual versions are acceptable.
